

Francisco Miró Quesada Cantuarias' Bibliography

Abstract

We present a bibliography of Francisco Miró Quesada Cantuarias' works divided by subject and subdivided by work type, and compare it with the last version of that made by Sobrevilla.

Keywords: Latin American logic, Peruvian logic, history of logic.

Introduction

Francisco Miró Quesada Cantuarias' work was great not only in quality, but also in quantity and diversity. The first attempt to list all of works was made by Peruvian philosopher David Sobrevilla in his book *Repensando la Tradición Nacional (Rethinking the National Tradition)*, Hipatia, Lima, 1986, Vol. 2, pp. 837–850). He updated this list for a collection in honour of Miró Quesada's seventieth anniversary [LRH, pp. 427–438] and later for the first volume of Miró Quesada's *Obras Esenciales (Essential Works)* [OE I, pp. 37–57].

Although Sobrevilla's work was remarkable, it had several gaps, probably because he had no access to all the bibliographic information that the Internet makes available to anyone today. Moreover, the works were not categorized by subject, but only by type into the following categories: (1) books, theses, and booklets, (2) academic articles, (3) translations, and (4) interviews, also including a section of works about Miró Quesada. Not counting this last section, Sobrevilla's bibliography has almost two hundred entries.

Here we present a bibliography divided by subject and subdivided by work type, including: (1) authored or edited books and booklets, (2) handbooks and textbooks, (3) dissertations, (4) (mostly academic) articles, (5) book chapters (including collections and proceedings), (6) reports and reviews, and (7) (apparently) unpublished works. We do not include newspaper articles because, being a leading columnist in Peru's most important newspaper (*El Comercio*)

for several decades, he has published too many. We have made exceptions for articles that were republished in some collection. We have nevertheless included all magazine articles of his authorship that we have found.

Considering these categories, we have listed about four hundred entries, some of which—it must be acknowledged—are republications or updates of previous ones. This was not uncommon in his times, as publishing in a South-American journal then was no guarantee that your paper made it into a European public library or even into one of another South-American country. In sum, our bibliography provides a list of Miró Quesada's works that is more exhaustive than Sobrevilla's. For example, we provide complete information for some entries [168, 229, 223] whose “place of appearance” could not be determined by Sobrevilla [OE I, p. 53].

We must however recognize our debt to Sobrevilla's work, which was the basis for ours, proving a great part of the information we include in the notes we make to some of the entries. We must also acknowledge that information about some of the new entries we include here was obtained in some of the notes made by Sobrevilla, where he often indicated later editions or republications of the entry. We have furthermore found information about some entries in other volumes of the essential works edited by him. However, a large part of what is new of our bibliography was achieved by our own research.

Unlike Sobrevilla, we indicate article and chapter republications as a separate entries unless they take place in a compilation of Miró Quesada's works, in which case we indicate it as a note. We have nevertheless decided not to include information about further book editions unless they were significantly different [e.g. 72, 179, 302, 306], in which case we have also indicated them as separate entries and explained their importance. We have listed as separate entries some chapters in compilations such that, to the best of our knowledge, had remained unpublished until that compilation was released.

As it is usual in this journal, we have included between parentheses a translation of the title into English. In order to save space, though, we only specify the language of publication when it is neither English nor Spanish, or when the title makes it ambiguous. After all, the vast majority of Miró Quesada's works were originally written or published in Spanish, although he has also published and written in English [1, 104, 111, 135, 149, 193, 223, 225, 226, 228, 229, 233, 235, 258, 293, 307, 344, 348, 349], French [85, 87, 89, 93, 99, 136, 148, 177, 189, 314, 315], and German [284], and also translated into Japanese [186].

Section 1 lists all planned (published and unpublished) volumes of Miró Quesada's essential works and Section 2 lists his other compilations. Section 3 includes all the collections we know to have been dedicated to him. These are the only works about Miró Quesada that we list of which he is not at least a co-author. Only the entries of these first three sections have custom shorthands, the rest being tagged numerically.

Section 4 contains works authored or co-authored by Miró Quesada about himself, the latter being interviews to him. Section 5 includes his writings about other authors, except for those that are best classified within a subject [e.g. 212, 226, 342]. We exclude article reviews and lecture remarks from this section, and include them in the reports and reviews subsection of each thematic section. We list his writings about Ortega y Gasset in special subsubsections because this was probably the author about whom Miró Quesada has written the most. The last subsection lists the books written by other authors that Miró Quesada has foreworded.

The remaining sections present a thematic classification of Miró Quesada's works, which is admittedly problematic. Many of his works deal with several subjects, and we probably did not always pick the best one for some works. Moreover, since we did could not access all of his works, we often had to classify them only considering their title or the references made to them in other works. Nevertheless, we considered it important to classify Miró Quesada's works for the reader, especially those related to logic (Sections 11 and 12), math (Section 13), reason (Section 7), and science (Sections 15 and 14) which would be of special interest to the readers of this journal. The last section lists those works that did not easily fit into the previous ones.

Unfortunately, most of our work was made during the coronavirus pandemic, at which time we could not physically access public libraries to collect information that would have reduced even more the gaps in our bibliography. Despite all those limitations, we think we are providing the most complete and detailed bibliography of the works by this great South-American philosopher, and which we will have time to improve. For this reason, we close this introduction the way he closed more than one of his works:

The second and fifth volumes of this collection have not yet appeared, and currently have no scheduled publication date. All the volumes contain works only in Spanish, either because they were originally written in that language, or because they were translated into Spanish for this collection.
